Terms and Conditions for Generative AI Tools and Features

5. Data Use and Monitoring

NI hereby warrants that it shall not store nor use any content, inputs and/or prompts provided by you as part of your use of any Tool in order to train its generative AI models and/or to train any of its Tools.

You hereby represent and warrant that you retain all rights to any content shared by you as part of or in connection with your use of the Tools (the "Content"). Your Content may be transmitted to NI to generate suggestions. You hereby grant NI a nonexclusive and limited license to store, access and use the Content as reasonably required for the provision of the Tools.
